Call to Order: 6:41pm

### **Guests:**

Jerry Owens: Clarance Saur & Brian Grabeck. Clarance puts on one of the best car shows in West Texas. The show has been an annual event in support of The Hope House across from Oncology. His wife has Stage IV cancer and he became involved with this organization and met a lot of good people, while going with his wife for her treatments. The Hope house helps patients in many ways; financially, provides a place to stay and food while receiving treatments, & support, to name a few. His wife was told at one point, after 4 1/2 years, all treatments have been tried without success and to prepare for the end. Another experimental treatment came out, and was in trials, but the cost per treatment was \$34,000.00. Since it's not FDA approved, insurance won't cover it. They applied to their insurance company for coverage. They received a letter from the insurance company giving them approval for 1 year of treatments for free. His wife is feeling good, has gone back to work and seems to be responding very well to the treatment. It's not chemo, it's a treatment that boosts the patient's immune system to kill the cancer cells (immunotherapy).
